## **Resume Template: Investment Banking**

- I. Background
  - Candidates should have a clean and updated resume handy, both physically and electronically, at all times during the networking process.
    - i. <u>Candidate</u>: An individual who would like to enter the investment banking industry.
    - ii. <u>Networking Process</u>: Events, conversations, and interviews that provide exposure to investment banking practitioners.
  - The resume is provided by the candidate to the practitioners and is used as a reference tool throughout the networking process.
    - i. The practitioners will refer to the candidate's resume for contact information and background on past work / educational experiences.
  - The candidate should attach a resume on all initial networking emails (especially cold emails).

## II. Tips and Tricks for Effective Resume Building

- Resumes should be proofed for spelling and grammatical errors.
- Resumes should be fully-accurate and up-to-date, and should never contain any false information relative to current or past positions.

- Physical resumes should be printed on professional resume paper, positioned in portrait orientation, and placed on an 8 1/2 in. by 11in. sheet.
- Resumes should be written to reflect the present scenario meaning that current experiences should be written in present tense and past experiences should be written in past tense.
- Resumes for junior candidates should be one page in length.
  - i. The only time a resume longer than one page is acceptable, is if the candidate is a senior practitioner and has a long list of relatable deal flow, publications, or licenses.
- If the candidate is currently in college, place educational experiences first and work experiences second.
  - i. If the candidate is currently in the workforce, list work experiences first and then educational experiences second.
- Be sure to include job-specific licenses and any relevant extracurricular activities or hobbies that could translate into a beneficial skillset for the position.
  - i. <u>For example:</u> college athletics, leadership roles, entrepreneurship, computer skills, participation in finance-related clubs or strategy-related clubs (e.g., chess club), musical instruments, language proficiency, and volunteer work.
- When including deal flow experience:
  - i. Use the client company's real name if the deal has been closed and is publicly available.
  - ii. Use the project code name if the deal is ongoing, if the deal is non-public, or if the deal failed to close.
